* Roxi discussed Robb Field flag football tournament on Jan 27.

Flag football tournament was scheduled with no prior notice to our league and games were not played on Robb 1 2, and 3. It was proposed to reschedule those games on Sundays at Alcott. Teams/games scheduled on Robb 1 would be rescheduled to Sunday, March 10, those scheduled on Robb 2 would be rescheduled to March 18 and those scheduled on Robb 3 would be rescheduled to March 24 (subject to field availability).

* Park and Rec may split into several separate departments. It is unknown what the impact to user groups would be. Rec centers will have to contract outside for field repairs beyond what the city would provide.

*Policy regarding phone calls when games are cancelled. A question came up with regard to possibly calling a second person on each team in the case where team rep may not receive the message about a game cancellation. Kanda suggested team reps contact the board with an alternate rep if the team rep goes out of town. It was also suggested that league be provided with cell phone numbers rather than home numbers . It was also suggested that each team have an alternate rep identified.

* Robb field will be unavailable from May 19-21 due to the USASA West Championship tournament. The men's league (SDCSL) is hosting the tournament and will do their best to accommodate any Sunday to make up these games. Rescheduling will be discussed at the next league meeting.

*Roxi will check field availability at Alcott for Sundays in March.

*Jackie asked for scores

* Reminder that teams should be using the roster form that can be downloaded (word.doc). Jackie is still getting old yellow roster cards. Refs are saying that games are starting late and it is our fault because cards are not filled out ahead of time.

* Michelle asked if there are any div 1,2,3 teams NOT going to Vegas (for scheduling purposes). Teams not going are Shooters, Arsenal, Bootleg, FA United, Still Kicking, Stingers.

*Julie talked about add/drops. Money and add/drops should be sent directly to Sherri. Indicate on the check or paper how many add/drops there are. You don't have to drop a player if they aren't playing.

*Sherri expressed appreciation regarding the ease of receiving digital photos, faxes, etc.
