

Sept 5, 2006 PWSL League Meeting Minutes

Called to order 7:34 p.m.

We have 36 teams. Schedules through September were passed out. 1 team backed out delaying further scheduling. All teams must have 2 jerseys so that home team can change color if there is a conflict. Penny's are available for about \$5 a piece. Carole has a source for deals on jerseys.

Current Board Member roster will be sent out to team reps for communication purposes. Jackie (statistician) requests that game scores be emailed to her after each game.

Sistered teams are: Nomo/More Magic/Magic, Still Kicking/30& Still Kicking, Hefeweizen/ Maxwell, Solymar/Solymar Too, Tsunami/Samba, Bootleg/Extreme, Huff N Puff/America United

Open-age division teams can sister with O30 division teams but the O30 can borrow only O30 players. This is the last session that O30A teams can register U30 players. As of Winter League all players on an O30 team must be 30 years of age in 2007. U30 players registered on an O30 team in the II will be grandfathered on that team only for future sessions until they are 30.

Registration issues: Pictures that were on a disc were very easy to deal with. Emailed pictures were more difficult to process. Please send color pictures on disc in the future. Please make sure if you are recruiting or registering a new player to a open division team that they are not registered on another open division team. For example, a player may not register on both a Div I and a Div II team. However, a player MAY register for one open division team and one 30s division team. Please do not have individual players send checks to Julie, the Treasurer. From here on out team reps do not need to re send their roster if they make changes. Sherry will make the changes to the official roster. Registration materials must be in to the registrar by Tuesday to be eligible for the following weekend game. Once all the ID information is in the PWSL system subsequent registration will be much easier (no need for new picture or DL).

Player cards will be brought to each field by a board member for the first game and left with the referees for the later games. Cards for games at Lindbergh will be in the Lindbergh shed.

What we lose with the new affiliation is health insurance (which was used by VERY few players). Also, if teams participate in an Affiliated tournament requiring certification USSSA charges \$75 for the paperwork. The affiliation provides a \$2 million liability policy (compared to \$1Million thru CSAS).
